Town of Coventry (Owner) is requesting Bids for the construction of the following Project:

Coventry High School Sewer Extension

Bids for the construction of the Project will be received by the Town Clerk located at 1670 Flat River Road, Coventry, Rhode Island 02816 until **June 5, 2025**, at **1:00 PM** local time. Three (3) copies of the bid shall be submitted in a sealed envelope clearly marked **Coventry High School Sewer Extension** to identify the bid. At that time the Bids received will be publicly opened and read at the Town Council Chambers.

The Project includes the following Work:

The Coventry High School Sewer Extension Project consists construction of approximately 3,400 linear feet of 18-inch gravity sewer and approximately and 1,400 linear feet of 8-inch gravity sewer, inclusive of manholes, lateral connections, Mishnock River crossing, restoration of unpaved areas to existing conditions or better, temporary trench repair, permanent trench repair, and State/Town Road Mill and Overlay. In conjunction, Water Main Improvements will take place within the project area and include 1,750 linear feet of 12-inch water main, 100 linear feet of 8-inch water main, 100 feet of 6-inch water main, service connections, appurtenances and capping of an existing 10" water main.

The Project has an expected duration of **240** days.
