Such plan shall, among other things, show the proposed arrangement of land uses; transportation facilities; public facilities; utility systems; deteriorating neighborhoods planned for rehabilitation, redevelopment or renewal; and natural resources and historic sites to be preserved. The Planning Commission may hold public hearings on the Comprehensive Plan or elements thereof.
