Honorable Council,

November 28, 2023 marked one year since new leadership took the helm of the Coventry Town Council. This team has put in a tremendous amount of time and effort to keep our foot on the gas and continue to build upon momentum month after month to deliver results for this body and the residents of our community.

In that time, this Town Council has met more than 40 times to conduct the people's business. This required many hours of strategic planning and extreme flexibility to be able to not only execute the legislative priorities of this membership, but to navigate significant administrative transitions, and numerous, unanticipated obstacles along the way.

The following is a comprehensive, but not entirely exhaustive list of what this administration, Vice President LeBlanc, and me - as your President - have supported execution of in the past legislative year:
